### **Executive Committee Meeting Minutes**

The ASSP Star Valley Chapter Executive Committee met at Out Back Steak House in Lynchburg, VA on August 15, 2019. President Daniel Ashworth, Vice President Stuart Bowman, Programs Chair Carlton Davis, Government Affairs Chair Bob Drane and Secretary Bob Calhoun were in attendance. The following items were discussed.

- Meeting Presentations
- Carlton is inquiring regarding the availability of a presentation "First 72: Are You Prepared?" This emergency management presentation was conducted in Roanoke in early August. It is thought that this presentation would benefit the membership.
- OSHA update regarding changes is always valuable and popular. An OSHA representative is to be contacted.
- Sharing of best practices from membership, this could be based on the 2019 OSHA Top 10 violations.
- Fire-related: tours of fire departments/presentation of techniques/fire prevention topics as October is fire prevention month. Participation from local fire departments was identified as possibilities. Carlton was a contact with the Roanoke Fire Marshall.
- Nurse related presentation to take advantage of joint meetings was suggested. Continued attempts will be made to contact the Occupational Health Nurse organization
  - $\circ~$  A baseball night out will be considered at the Salem Red Sox or Lynchburg Hillcats in June 2020.
  - Vendor's night safety supplier/services exposition will be considered. Bob Drane will contact a Grainger representative
  - o A presentation related to VA state parks/wildlife service was suggested
- An electrical safety presentation was recommended. Bob Drane has expertise on this topic as well as fleet safety and a DoT topic in which he can present.
  - Police-related tour/presentation. The attendees knew several police/hazmat officials that could provide a Chapter presentation.
  - Brewery/winery tour. Ballast Point Brewery in Daleville was identified as a potential site.
- A behind the scene tour of the Roanoke Coca-Cola plant was recommended. Carlton has a contact.
  - Financial planning presentation. Daniel has a contact that could be utilized for a January-February presentation.
  - Behind the scenes at a local college, challenges (chemical safety etc.). A Liberty University behind the scenes was recommended.
  - Vehicle safety @ VT and Institute for Highway Safety were also recommended.
- Machine guarding and checklists were recommends.
- How to use the ASSP website was strongly recommended.
- Roanoke lunch/afternoon meetings were discussed. Additional discussion is needed on this topic.
- A laser safety presentation may be provided in September.

B. Officer training in Chicago. Several are interested in attending the training.

- C. Chapter challenges: The Chapter challenges of meeting attendance, our large geographical area responsibility and ways to stimulate the membership were discussed. Many of these issues are presented in the Chapter Operational Planning paperwork was shared and will be provided in an upcoming newsletter.
  - Stuart identified a need to develop a brochure to define the Star Valley Chapter, what we offer and the benefits that can be realized. Stuart's affiliation with Patrick Henry Community College can find immediate use. Daniel reported that that a brochure model has been developed by ASSP that can be utilized.
  - It was suggested that Liberty University be approached regarding a business case to develop a degree program in "safety".
- D. Virtual Training

Daniel provided an update. The region has taken on virtual training and identified plans for a pilot at the spring Regional Operating Committee (ROC). A topic schedule and link is to be established in which Chapters can access and use on a Chapter level.

- E. Methods to increase Chapter finances
  - It was suggested that raising dues is an immediate method to increase Chapter finances. The Chapter
    does not currently have a fund raising method. The operating costs of supporting regional operating
    committees, awards and other costs strain Chapter finances. The Star Valley Chapter has the lowest
    membership dues within the region. Any increase of dues requires a vote and a description of the
    added value of doing so.
  - Ideas discussed included company meeting sponsors and newsletter sponsors.
- F. Webpage upgrade and maintenance
  - Bob Calhoun accepted an action to determine needs and repair/replace webpage contents.
- G. ASSP chapter officer training.
  - Officer website training must be completed by the end of September to earn points towards the Chapter Achievement Award.
- H. Bylaws revision
  - Bob Calhoun identified plans to revise the bylaws that include defining standing committees as identified below and expand the Executive Committee to include committee chairperson. The revised bylaws will be distributed for review and approval this Fall.

The Summit is a day-and-a-half event with general and breakout sessions and a robust exhibit area. This is a great opportunity to both learn and network.



#### The only acceptable number of traffic fatalities is zero!

Drive Smart Virginia provided some sad news: Boxing legend Pernell "Sweet Pea" Whitaker was struck and killed by a motor vehicle as he crossed a street in Virginia Beach this past July. Whitaker, who was 55, died at the scene.

He was a world champion in four weight classes during his boxing career and a gold medalist for the U.S. in the 1984 Olympics.

Whitaker fought in several "superfights," including matches against Julio Cesar Chavez and Oscar de la Hoya. He was 55 years old. Pernell was only one statistic:

- Last year, 123 pedestrians died as a result of collisions with motor vehicles a 7.9% increase compared to 2017.
- 13 bicyclists, 568 drivers, and 128 passengers died because of traffic crashes during the same period.
- In 2018, Virginia averaged one traffic crash every 4 minutes!
- Each day, 2.2 lives were lost and 182 people were injured on Virginia's roadways.

### **Traumatic Brain Injuries (TBI)**

According to a report by the National Institute for Occupational Safety and Health (NIOSH), a high number of American workers were seriously injured or died on the job due to traumatic brain injuries.

Falling 25 feet to the ground from a roof, being struck in the head by a steel beam as it is transported across a worksite, or getting hit by a vehicle moving supplies–these are only a few examples of why the construction industry has the greatest number of both fatal and nonfatal traumatic brain injuries (TBIs) among U.S. workplaces. From 2003 to 2010, 2,210 construction workers died because of a TBI (a rate of 2.6 per 100,000 FTE workers). These deaths represented 25% of all construction fatalities and 24% of all occupational TBI fatalities during the same period.

The numbers are tragic but there is some good news: the rate of fatal TBIs in construction decreased by 6.2% each year between 2003 and 2010. Some of this decline can be attributed to the overall decline in the rates of work-related deaths and fatal TBIs (including that are both work- and nonwork-related). Another reason is that spending and employment in construction decreased when the economic recession hit in 2007 resulting in fewer workers exposed to construction hazards. Despite these declines, TBIs remain one of the major causes of deaths in the construction industry.

### How common are TBIs in construction?

Researchers at the National Institute for Occupational Safety and Health (NIOSH) recently took a close look at deaths due to TBIs in the construction industry in the United States during 2003 to 2010. Their 2016 report in the American Journal of Industrial Medicine describes findings such as these:

- Workers in small construction companies (<20 employees) were more than 2.5 times more likely than those in larger companies (≥100 employees) to die from a TBI.
- Males were 7 times more likely than females to die from a TBI.
- Older workers (≥65 years) were almost 4 times more likely than younger workers (25–34 years) to have a fatal TBI.
- The TBI fatality rate was significantly higher for foreign-born than for native-born workers.
- Falls, especially from roofs, ladders, and scaffolds, led to >50% of fatal work-related TBIs.
- Structural iron and steel workers and roofers had the highest fatal TBI rate, and TBIs related to falls caused most of their deaths.

### Three strategies to heightened safety on the job site:

- 1. **Plan ahead.** When workers make a plan before engaging in an activity, they are more likely to set up safeguards and complete the job detail safely. Planning ahead also gives workers an opportunity to have a conversation with supervisors about fall (and other) hazards they see.
- 2. **Provide the right equipment.** Using the right equipment for the job greatly reduces accidents, injuries and fatalities, especially when working at heights.
- 3. **Train everyone on how to use the equipment safely.** Training has been shown to call attention to specific hazards on their worksite. Normal work is paused and the entire crew can focus on safety issues.

Long hospital stays, extensive rehabilitation, medication costs, vocational retraining and possibly even a live-in caregiver or nurse can all be the result of a severe brain injury. According to the Brain Injury Law Center, a serious brain injury can exceed six figures in the first year. And it can take months or years – to recover.

### How do we protect workers from TBIs?

Armed with the data above, safety and health professionals can work to prevent fatal TBIs in construction. A nationwide construction falls-prevention campaign, started by NIOSH, OSHA, and the CPWR—The Center for Construction Research and Training, seeks to raise awareness by encouraging everyone in construction to work safely and use the right safety equipment while working at heights, such as on roofs, ladders, and scaffolds. The Safety Stand-Down, stemming from the campaign, will occur during May 2-6, 2016. Also, to prevent falls from ladders, a NIOSH smartphone application provides visual and audio signals and safety tips for safe ladder positioning has been downloaded to over 63,000 smartphones as of January 31, 2016.

Improved harness sizing designs for protecting workers from falls due to poor fit or improper size selection; and a worker-support bracket and safety rail assembly that provides a guardrail system to protect workers from falling through unprotected roofs are among a few other NIOSH research studies that address falls.

Construction is a dangerous industry, and its workers are at high risk for TBIs and their life-threatening or lifelong consequences. Thus, despite the drop in fatal TBI rates in construction, prevention efforts addressing these injuries continue to be implemented and improved, especially among high-risk workers.
