### **August 3rd Virtual Webinar Recap**

Twenty-four people participated in the first ever Star Valley-sponsored webinar. Members from the Delmarva and National Capital Chapters also participated.

The presentation entitled "The New Virginia COVID Standard for Workplaces: What You Need to Know" was given by Courtney Malveaux, an attorney who represents employers in OSHA matters. The presentation featured an interactive discussion about the new COVID-19 requirements, with a heavy emphasis on the Virginia-unique requirements. The Virginia Safety and Health Codes Board (which includes the presenter) passed a first-in-the-nation standard to address COVID-19 in workplaces. Virginia Occupational Safety and Health (VOSH), the state's version of the Occupational Safety and Health Administration (OSHA), now will enforce a standard that mandates — and in some instances exceeds — guidance issued by the U.S. Centers for Disease Control and Prevention (CDC) and OSHA. The new standard covers most private employers in Virginia, as well as all state and local employees.

Mr. Malveaux is Virginia's immediate Past Labor Commissioner and a former President of the National Association of Government Labor

Officials. He represents industrial employers on the Virginia Safety and Health Codes Board, which approves OSHA standards for Virginia employers.

The webinar was a great success and provided some timely information. This was Courtney's third time addressing our Chapter.

### **3-T's Will Prevent Dropped Objects in Construction**

Dropped objects are a leading cause of injuries to construction workers. Fortunately, there's a powerful memory device that can help safety professionals respond. Just as personal fall prevention provides the ABCs (anchor, body support, connectors), dropped object prevention involves the three Ts.

### **Trapping**

- Trapping describes the installation of retrofit attachment points on tools and primary anchoring locations.
- Install anchor attachments on secure locations and remember they are never intended for heavier tools if applied to a person.

#### **Tethering**

- Tethering means attaching tools and equipment to the anchor points that hold them, and it often involves use of lanvards.
- You can even adapt tools that seem untetherable, because they lack attachment points, for safety.

### **Topping**

- Topping refers to the containers that workers use to bring tools and equipment to and from heights.
- Make sure these containers have secure closures or tops that can cover the contents and prevent them from spilling if tipped.

### **House of Delegates Report: HoD Votes to Approve Bylaw Changes**

The 2019-20 House of Delegates has voted to approve proposed bylaws changes. Voting by 2019-20 delegates began on May 15, 2020 and concluded on July 6, 2020. Fifty percent of the delegates voted, compared to 49% voting in previous delegate e-votes. The voting breakdown is as follows:

Motion 1: Approve the revised bylaws language to bring ASSP into compliance with Illinois state law for non-officer board members.	123	0	0	100%
Motion 2: Approve the bylaws language clean-up to clarify that practice specialty and common interest group administrators shall not serve more than one full term in the same office, consistent with all other elected officers and current procedure.	118	3	2	96%
Motion 3: Approve the bylaws language clean-up, adjusting the public director term to a three-year term, bringing consistency to ASSP Board of Director terms.	123	0	0	100%
Motion 4: Approve the bylaws language clean-up to add senior vice president as ex-officio member to councils and board committees to bring consistency across all councils and board committees.	122	0	1	99%
Motion 5: Approve the bylaws revision to the make-up of the council on practices & standards to include current elected administrators and a vice-chair.	119	2	2	97%
Motion 6: Approve the bylaws revision to move the Standards Development Committee to be a board standing committee.	119	4	0	97%
Motion 7: Revise bylaws language, removing the professional member requirement for the elected positions of regional vice president, area director, practice specialty/common interest group administrator, and practice specialty/common interest group assistant administrator.	94	29	0	76%



The 7th Annual National Safety Stand-Down to Prevent Falls has been rescheduled for September 14-18, 2020. OSHA is partnering with other safety organizations to encourage employers to provide safety demonstrations on fall protection equipment, conduct talks regarding fall-related hazards, safety policies, goals and expectations, and promote the event by using the #StandDown4Safety on social media.
