The meeting followed the following format.

 Welcome comments: President Carlton Davis welcomed the attendees to our second ever virtual meeting.

2. Chapter Business:

- Our two newest members Dr. Diana Schwerha and Jesse Phillips, CIH were welcomed and introduced. Diana is a professor at Liberty University and Jesse is employed by Froehling and Robertson at their Roanoke Branch.

3. Presentation:

We were honored to have *Wyatt Bradbury* speak at the meeting. Wyatt Bradbury serves as a HSE Advisor for Hitachi Rail and is part of the Department of Engineering Faculty and the University of Alabama Birmingham teaching Professional Ethics and Introduction to System Safety for the Advanced Safety Engineering and Management Program. He has experience in aquatic and recreation risk management, electrical construction, power line safety, rail safety, and safety consulting. Mr. Bradbury holds CSP, CHST, and CIT certifications from the BCSP and a Master of Engineering in Advanced Safety Engineering and Management from the University of Alabama Birmingham.

Wyatt is a Past-President of the National Capital Chapter, on the Chapter Leader Training Committee under the Council on Regional Affairs, on the planning committee of the Mid-Atlantic Construction Safety Conference, and is a member of the Emerging Professionals Common Interest Group. Bradbury currently serves as the National Capital Chapter Delegate and as the Assistant Regional Vice President of

Communication for Region VI. He regularly travels the country speaking at local and regional professional development conferences and is a frequent contributor to Professional Safety Journal.

<u>Presentation</u>: Creating Successful Virtual Engagement Using the Equation: (Purpose x Platform x Setup) + (Content x Engagement) = Successful Virtual Program

This presentation demonstrated how to generate successful virtual programs. Some key points are noted below.

- 1. Determine what are we trying to accomplish.
- 2. Determine the platform to be used. "Go-to-meeting" is used by ASSP Region 6 and the Chapter pays for this. Zoom is free.
- 3. Setup considerations:
 - a. How is registration to be accomplished? Care is needed to control logon security to avoid potential disrupters.
 - b. How is the event going to marketed? Many choices were identified: email, social media, newsletters, the ASSP website hub, etc. The goal is to maximize the reach.
 - c. Presentation options can include many things including training, auditing, etc.

4. Content

- a. Slides are not always needed.
- b. It is suggested that students be provide input and even present (project/education status etc.)
- c. Chapter members can be spotlighted.
- d. Collaboration with other Chapters is a means to accomplish several objectives.

5. Engagement

- a. A moderator is needed.
- b. It is important to address the participants. Ask for experiences, feedback, etc.
- c. Take advantage of the technology and the experience of attendees.
- d. Engage early, identify expectations and seek participation.
- e. Acknowledge the limitations with participant's means of access: mobile, desktop, web and the limitations that could be created.

6. Follow-up

a. Identify follow-up techniques that could be utilized: recordings, session summaries, social media and future events.

7. Sources of information

a. ASSP Community Platform, Region 6 communication has established a source for "tips & tricks"

A question and answer period followed the presentation that created lively response and excellent information exchange and discuss how to tailor these virtual engagement opportunities to our Chapter. Some of the discussion centered around

- Marketing (Mayday Marketing was identified a possible source),
- Graphic design (may utilize the assistance of personnel who dabble in this arena).
- Assignment of CEUs. There are options that require some research and cost determination.

4. Concluding remarks

- Many thanks to Wyatt for his presentation. This information will benefit the Chapter conduct virtual training so important in this time and especially appropriate to our Chapter that serves 27 counties in Virginia.
- Attendees were reminded to provide a list of preferred virtual presentations and recommend presenters who may be interested in conducting virtual information exchanges.

In Recognition of Career Contributors

As a part of the newsletter contribution effort, I'm honoring one of my most influential college professors Robert (Bob) McClay Jr. From his obituary and the Indiana University of Pennsylvania's (IUP) Department of Safety Sciences website:

Bob McClay, 82 of Indiana, PA passed away peacefully at home, surrounded by his loving family on January 24, 2021 after a 15-year battle with Parkinson's Disease.

Bob graduated from Bucknell University in 1959 with a degree in Chemical Engineering. He later earned an MBA from American University and completed graduate studies in Ergonomics and Industrial Engineering at North Carolina State University. Following his graduation from Bucknell, he worked a short time and then attended Officer Candidate School for the United States Navy, serving on the USS Bayfield during the Cuban Missile Crisis and the Vietnam War.

He was one of the founding professors of IUP's Safety Science program where he taught for nearly thirty years and was instrumental in building the department into the first nationally accredited program. Bob is credited with developing the majority of the courses taught in the program, was instrumental in the development of the Master of Science in Safety Sciences program in 1983, and served as department chairperson from 1974 to 1975 and again from 1982 to 1985.

Bob was active in many professional organizations and truly dedicated to the advancement of the profession. He led and served on many committees and held numerous leadership positions for the American Society of Safety Engineers. He was a dedicated professor and took great pride in the accomplishments of his students. He loved catching up with alumni and reminiscing about their time together. He traveled the country in support of the profession and was also actively involved in the Board of Certified Safety Professionals, The System Safety Society, The Society for Risk Analysis and the National Fire Protection Agency (NFPA). Bob was always willing to support any initiative that would further efforts in improving workplace safety and health and one of his proudest honors was being recognized as an ASSE Fellow in 2003. After his retirement from IUP, as Professor Emeritus, he taught at East Carolina University for five years.

Not only was Bob a superior instructor and renown subject matter expert he was also a friend to many of his former students including myself. I always looked forward to seeing him at the ASSP National Professional Development Conference IUP alumnus get-togethers' where he attended almost every year until his illness prevented his participation. Bob's dedication to his profession and to his students was impeccable and he remembered each and every student often with humorous antidotes.

As the IUP Department of Safety Sciences website stated: "To say he was a "rock star" in the department is an understatement. Alumni continue to ask about him to this day, and are always happy to share wonderful memories of a beloved professor who made them work hard to reap the benefits of a thriving profession". A great resource and friend was lost but the memories and his legacy continue as he inspired many.
